Minutes

Kevin moved, seconded by Clarence to approve the minutes of February 7th. Voted yes 3-0; 2 abstentions.

Clarence moved, seconded by Kevin to approve the 2 sets of non public session minutes of February 7th. Voted yes 3-0; 2 abstentions.

Tad moved, seconded by Jack to approve the non public session minutes of January 31st. Voted yes 5-0.

2011 Budget & Warrant

The Selectmen signed the 2011 Budget & Warrant.

Linda corrected the article Betty Hall had in the paper that the selectmen refused to put a report from the finance committee in the town report. The selectmen did not refuse. Their report was submitted too late for the printing of the town report.

Town Hall

After some discussion *Clarence moved, seconded by Jack to allow the Souhegan Valley Karate Club to put up 6' high mirrors on the back walls of the upper town hall with the understanding that they can be removed, if necessary. The Club will save the chair rails. Voted yes 5-0.*

RSA 540:1-b Landlord's Agent Required

Town Clerk/Tax Collector Patti Howard-Barnett submitted a copy of RSA 540:1-b Landlord's Agent Required. (copy attached) **Patti** said some of towns are charging a fee and asked the selectmen's opinion. The selectmen said they would defer to Patti to make the decision.

Milford District Court

An email was received from Guy Scaife of Milford that Gov. Lynch has put funding in the budget to keep the Milford District Court open for the next 2 years and for "feasibility/design" for a new court building at the state police barracks.

Cable Contract
