Minutes Board of Selectmen Monday, February 7, 2011

Selectmen Linda Saari, Clarence Farwell and Kevin Gorgoglione were present.

Linda moved, seconded by Kevin to go into non public session under RSA 91-A: 3, II, (c). Voted yes 3-0.

On returning to public session, Linda moved, seconded by Clarence to seal the minutes. Voted yes 3-0.

Energy Lighting

Ernie Pistor and Sue Adams were present. Ernie said he contacted Sue Adams to work with him as the town needs a coordinator with LighTec to get the energy lighting project done. Sue said they met with Anne at PSNH and the contracts are not ready to sign at this time. The Selectmen gave Sue their support to work on this project. Clarence said he questioned over a year ago whether this project would actually happen. Kevin moved, seconded by Clarence to have Sue Adams as the coordinator for the town with LighTec, TRC and PSNH and authorize her to sign any necessary paper work. Voted yes 3-0.

Police

Pat Cambray asked what's going on with the police department and asked if the department is short handed. Linda confirmed that Mike Kurland is on paid administrative leave. She said Chief Quigley has worked with the union members on a new schedule which is helping cover the shifts. Linda said she has confidence that Chief Quigley is taking care of things. Jay Chrystal said everyone knew that Quigley would be a 37 hour per week employee before he was hired. Sue Adams said this practice is not unusual. Michelle Dowling asked about the DARE Program. Linda said she would have to ask Chief Quigley about that.
