## Minutes Board of Selectmen Monday, January 10, 2011

Selectmen Linda Saari, Clarence Farwell, Kevin Gorgoglione, Tad Putney and Jack Flanagan were present.

## **Library**

Library Trustee **Betsy Solon** was present. The trustees returned \$4,978.37 to the town for unspent salaries.

### Karate

**Rena** reported that the Karate group donated \$1,000 to the town for their use of the upper town hall.

## **Town Report**

**Ann Somers** brought in a proposed town report cover with pictures of Sonny Farwell and Joe Joki. **Clarence** will show it to Lucille Farwell and Esther Joki.

#### SRLD

**Jerry Farwell** was present to discuss the process for adopting the amended Souhegan Regional Landfill District Agreement. The four towns (Amherst, Hollis, Mont Vernon and Brookline) have to pass a warrant article to amend the Agreement. **Rena** will check with Troy in Hollis on what they are doing.

#### **Off-Site Improvement Agreement**

Jerry Farwell and Al Patenaude were present to discuss off-site improvements for the subdivision of lots J-41-1 and J-41-3 off Laurelcrest Drive, Baldwin Drive and Averill Road. Al said he feels an off-site improvement fee of \$1,500 per lot is excessive along with Impact Fees for a Workforce Housing development. There are 14 lots in the subdivision; 7 regular lots and 7 workforce housing lots. Al said he increased the length of the common drive per the planning board request. After several suggestions Jack moved, seconded by Tad to assess \$750 per lot for the 14 lots in the subdivision. Voted yes 4-0; Clarence abstained.

## **Cross Road/Route 130**

The Selectmen discussed the Cross Road/Route 130 intersection with road agent Jerry Farwell. **Jerry** said if Cross Road was one way going to So. Main Street, it would be very difficult for tractor trailer trucks to get onto So. Main Street at the corner of the cemetery. It was suggested to put in Dangerous Intersection and Use Directional signs. **Tad** will draft a letter to the DOT for next Monday.
