Minutes Melendy Pond Management Committee (MPMC) Monday, December 9, 2019

Attendees at the meeting included Eddie Arnold, Brendan Denehy, Tom Solon, Randy Haight and Tad Putney.

Eddie called the meeting to order at 6:30pm.

Minutes

Brendan moved, seconded by Randy, to approve the public and non-public minutes from the October 14, 2019 meeting as written; Voted Yes 5-0. Brendan moved, seconded by Tom, to approve the non-public minutes from the November 4, 2019 meeting as written; Voted Yes 5-0.

Agenda Adjustments

Legal Fees

Tad reviewed the two legal invoices that were received and paid related to work on the new leases. He noted that the total legal costs were \$11,398.50, including the Assignment of Lease document for a tenant who may sell their structure in the future.

Tenant Follow-up on New Leases

Tad said in early November he mailed out follow-up letters to all tenants we had not heard from regarding the new leases. **Tom** asked if we should send out another reminder letter. Members agreed. **Tad** will incorporate suggested edits from **Tom** into the letter.

Update on New Lease Signings

Tad said five new leases have been signed and only two tenants have advised that they will not be signing a new lease. He said he has spoken with three other tenants about the new leases. **Tad** noted one of the new leases was signed by the individual who is purchasing the Tucker's structure.

Update on Invoices for New Leases

Tad advised that he sent out the invoices to the new leaseholders with a due date of January 1st for their first rent payments.
