6:30pm **Eddie** opened the meeting with the Pledge of Allegiance and read the ground rules for hybrid meetings. FinCom meeting called to order: Graham Loff and Daniel Koenig. *Eddie moved, seconded by Ed, to go into non-public session per RSA 91-A:3 II (a) personnel; Roll Call Vote Yes.*

6:45pm *Eddie moved, seconded by Brendan, to come out of non-public session and seal the minutes; Roll Call Vote 5-0.* Resume public meeting already in session.

Conservation Commission Brendan Denehy proposed \$44,500 Level Funded Warrant Article CC P&S Agreement for 50% ownership of estimated 250 Acres of land in the northwest quadrant owned by the Denaults, \$2,175k.

Assessors/Revaluation – Bret Hall Proposed \$40,422.

WA Elderly Exemption Adjustment to Single and Married.

WA 5 Year Valuation Amortization \$20k for years 2024, 2025, 2026 and 2027 and budget the balance in the 5th year if needed.
