Minutes Selectboard – Budget Hearing Tuesday, January 29, 2019

Selectboard members present: Brendan Denehy, Eddie Arnold, Tom Humphreys, Valerie Ogden and Ron Olsen along with Town Administrator Tad Putney. Also present: Finance Committee members Brian Rater, Linda Chomiak and Steve Russo, residents Ann Somers, Drew Kellner, Roger Ogden, Eric Pauer, Peter Webb, Peter Cook, David Coffey, David Partridge, Pat Leonard, Cindy Lacroix.

7:00pm - Brendan reconvened the budget hearing from Monday, January 28, 2019.

**Tad** said he spoke with **Chief Quigley** who informed him there was a calculation error with regard to the 2019 police salaries. The correct amount for salaries is \$689,138, resulting in a revised proposed police budget of \$841,841.

Emergency Management – David Coffey – Proposed budget of \$21,550.

**Library – David Partridge –** Proposed budget of \$257,567.

**Election & Registration** – **Tad Putney -** Proposed budget of \$3,700, which is down due to only one election this year compared to three last year.

Planning & Zoning – Tad Putney – Proposed budget of \$64,557.

**Economic Development – Tad Putney –** Proposed budget of \$4,350. **Tad** said the increase of just under \$1,000 is for the planned welcome signs for the business district on Route 13. **Drew** asked the Board to consider increasing the amount because he thinks it is under budgeted for the signs.

**Financial Administration** – **Tad Putney** – Proposed budget of \$210,568. Increased for IT-related costs, including: replacement of desktop computers, a Fire Department server and three rhino pads for the police cruisers.

**Revaluation of Property – Peter Cook –** Proposed budget of \$31,932. **Peter** said the line items "Updates/BTLA Expenses" and "Data Verification" have merged together as one titled "Contract Assessing; Cyclical Inspections". Reviewed related warrant articles with no changes.

**General Government Buildings – Tad Putney – Proposed budget of \$216,285.**

**Personnel Administration – Tad Putney –** Proposed budget of \$558,926.

Executive – Tad Putney – Proposed budget of \$226,206.

**Debt Service – Tad Putney –** Proposed budget of \$294,738.

**Cable Access – Tad Putney –** Proposed budget of \$17,795.

**Insurance – Tad Putney –** Proposed budget of \$68,622.

**Revenues – Tad Putney** – Estimated revenue \$2,075,154.57.

Prior to voting on the operating budget warrant article, **Tad** asked the Board if they wanted to increase the Economic Development "Welcome Sign" amount as **Drew** suggested. *Ron moved, seconded by Eddie, to increase the Economic Development* "Welcome Sign" amount to \$5,000; Voted Yes 3-1-1; Val voted no, Tom abstained. Revised Economic Development budget of \$7,350.
