Minutes Selectboard Monday, November 25, 2013

Selectboard members Darrell Philpot, Karl Dowling, John Carr, Susan Adams and Brendan Denehy were present along with Town Administrator Tad Putney.

Also present were Keith Thompson, Brian Rater and Ann Somers.

Darrell opened the meeting with the Pledge of Allegiance.

Brendan asked for a moment of silence on the passing of Deputy Fire Chief Curt Jensen.

Minutes

Brendan moved, seconded by Sue to approve the public session minutes of November 12th. Voted yes 5-0.

John moved, seconded by Brendan to approve the non public session minutes of November 12^{th} . Voted yes 5-0.

Warrants

The Selectboard approved Warrant # 48 in the amount of \$827,136.82 and payroll in the amount of \$43,766.69.

Workforce Housing Position Statement

The Selectboard agreed to take no action on the request for a Survey Position Statement regarding Workforce Housing laws.

Proposed 2014 Pay and Benefits

Tad presented the impact of proposed 2014 pay and benefits for town employees. The proposed increase for wages is 2% for non union employees plus the employee's portion for health insurance increase to 10% from 5% in 2013.

Building Inspector

Tad noted that the building inspector will retire at the end of the year. He said he has interviewed 3 candidates for the vacancy and is in the process of doing background checks.

<u>Proclamation - Curt Jensen</u>

Darrell read a proclamation on Deputy Fire Chief Curt Jensen's many years of service on the fire department and declaring Tuesday, November 26th 2014 as Curt Jensen Day.

Jensen Funeral

Tad announced that Route 130 from the Safety Complex, Meetinghouse House Hill Road and Bond Street to Cross Road will be closed tomorrow from 10:45 am to between noon and 1:00 pm for the Jensen funeral. The meeting room, upper town hall and fire station will be open for overflow from the church. Parking will be available at the ball park and Bingham Lumber. Buses will be available

Public Hearing

Darrell read the public hearing notice to accept unanticipated revenue in the amount of \$11,277.25 in Highway Safety Grant funds for additional police patrols and \$24,950 for reimbursement of paid Details with the funds to be expended by the police department. Chief Quigley said the officer gets \$40 per hour for a detail and the vendor is charged \$52 per hour or \$59 if it includes a cruiser. Tad said we are looking at a warrant article at March Town Meeting to create a revolving fund for police details. John moved, seconded by John to accept the unanticipated funds. Voted yes 5-0.

Non Public Session

Darrell moved, seconded by John to go into non public session under RSA 91-A: 3 (a) dismissal, promotion, or compensation). Voted yes 5-0.

On returning to public session, Darrell moved, seconded by Karl to seal the minutes. Voted yes 5-0.

Meeting adjourned at 7:30 pm.
