Minutes Selectboard Monday, February 3, 2014

Selectboard members John Carr, Susan Adams and Brendan Denehy were present along with Town Administrator Tad Putney.

Also present were Helen Ballou and Ann Somers.

John opened the meeting with the Pledge of Allegiance.

Conservation Commission

Brendan announced that Tuesday, February 11th Randy Haight of Meridian Land Services will be at the conservation committee to discuss the wetlands permitting process.

Minutes

Brendan moved, seconded by Sue to approve the public session minutes of January 21^{st} , 22^{nd} and 31^{st} . Voted yes 3-0.

Sue moved, seconded by Brendan to approve the non public session minutes of January 21st, 22nd and 31st. Voted yes 3-0.

Warrants

The Selectboard approved warrant # 5 in the amount of \$951,892.43 and payroll in the amount of \$46,266.21.

The Selectboard reviewed the disbursements through January.

Audit Engagement Letter

Sue moved, seconded by Brendan to authorize John to sign the engagement letter with Plodzik & Sanderson for the 2013 audit. Estimated cost is between \$11,500 and \$14,500. Voted yes 3-0.

Brookline Safety Manual

Tad explained that the town is required to review and update the Brookline Safety Manual, as needed, every two years. Brendan moved, seconded by Sue to approve the amended Brookline Safety Manual. Voted yes 3-0.

Intersection of Route 13/Route 130

Tad reported that the DOT got approval for an expedited review of the intersection of Route 13 and 130. Tad expects to hear from them tomorrow. It's possible some type of improvement to the intersection could be done this year.
