Minutes Selecthoard Monday, March 3, 2014

5:30 pm - Selectboard members Darrell Philpot, Karl Dowling, John Carr, Susan Adams and Brendan Denely were present along with Town Administrator Tad Putney. Also present were Brian Rater, Linda Chomiak and Peter Webb.

Darrell opened the meeting with the Pledge of Allegiance.

Minutes

Sue moved, seconded by Brendan to approve the public session minutes of February 18th. Voted yes 4-0; John abstained.

Brendan moved, seconded by Sue to approve the non public session minutes of February 18th. Voted ves 4-0; John abstained.

Warrants

The selectboard approved warrant # 9 in the amount of \$969,750.43 and payroll in the amount of \$43,725.79.

Tom Dwyer

Darrell read a Proclamation to Tom Dwyer for his dedication as a firefighter and time he served on boards in the town. Tom passed away last Thursday.

Highway Budget

The selectboard discussed the proposed highway budget. We have spent \$145,600 for snow plowing so far this year and \$132,400 is budgeted. **Tad** said Jerry suggested increasing the proposed budget by \$50,000 or take it out of resurfacing and drainage. The Selectboard decided to split the difference. Add \$25,000 to the proposed budget for plowing and spend from resurfacing and drainage, if needed.

T.E. Grant for Sidewalks

Tad said we can reduce the amount to be raised by taxes in article 10 to \$43,000.

Conservation Commission - 2014 Recreational Trails Grant

Tad said the conservation commission asked for the Selectboard's support in applying for a Recreational Trails Grant for 3000' of the rail trail from So. Main Street to Bohanon Bridge. *Brendan* moved, seconded by Darrell to authorize Darrell to sign the grant application. Voted yes 5-0.
