Minutes Selectboard Monday, August 4, 2014

Selectboard members Darrell Philpot, Susan Adams, John Carr and Brendan Denehy were present along with Town Administrator Tad Putney.

Also present were Ann Somers, Loring Webster, Keith Thompson and Drew Keller.

Darrell opened the meeting with the Pledge of Allegiance.

### Public Input

**Loring** said he and Ann walked the new sidewalk yesterday and it was delightful.

### Minutes

John moved, seconded by Brendan to approve the public session minutes of July 21st. Voted yes 4-0.

### Warrants

The Selectboard signed Warrant #31 in the amount of \$1,410,028.66 and payrolls in the amounts of \$43,317.68 and \$760.

### **Town History Committee**

The Selectboard signed a new 2014 Town History Committee Charter to expire at the conclusion of the March 2015 town meeting. Committee to consist of up to eleven permanent members appointed by the Selectboard and additional ad hoc members at the discretion of the committee. **Keith** said he would like the Selectboard to appoint Vicky Pope and Donna Corey to the committee. The Selectboard will address the appointments at their next meeting.

### Transportation Alternative Program

The Selectboard signed a letter of interest to participate in a grant to continue building new sidewalks. The next sidewalks would be along Route 130 from So. Main Street to Bohanon Bridge Road and Old Milford Road from the top of Steam Mill Hill Road to Rocky Pond Road. Estimated cost is \$625,000 of which the town would pay 20% or \$125,000. If approved for the grant, the town would vote on our 20% at the next town meeting.

Tad said he expects the existing sidewalk project will be under budget by \$35,000 to \$40,000.

### Treasurer

Tad said he received 4 applications for the treasurer's vacancy at the end of September. He is in the process of meeting with them and expects to have a recommendation at the next meeting.

### **Recreation Commission**

The recreation commission has asked the Selectboard to appoint Derek Dvareckas to the commission. The Selectboard will address the appointment at their next meeting.

### NH Site Evaluation Committee

**Tim Drew** of the NH Site Evaluation Committee was present. The Committee was established by the legislature for the review, approval, monitoring and enforcement of compliance in the planning, siting, construction and operation of energy facilities. At least two public hearings are required in the county where towns are impacted. The timeframe of an application is attached. The Committee will consider other alternatives. ### Capital Improvements Plan

Tad submitted a proposed plan for the next 6 year CIP for town buildings. Brendan said he would like to keep the new library in the plan and would like to put the cost for an architect in 2017 with the library in 2018. The library trustees will be asked to come to the next meeting to get their opinion. Darrell said he's concerned with always increasing taxes. Drew Keller said it would be a benefit to both Brookline and Hollis to have a regional compromise in their libraries and save money for both towns. Sue said she would like to keep the present library and have it declared a historical building in order to apply for grant money. Brendan said he would like a line item for energy saving projects.

### Eagle Scout Alex Merryman

The Selectboard signed a letter of congratulations to Alexander Merryman on his completing the Eagle Scout rank. His project was to build a new sign in front of the Brookline Community Church.

### **Ambulance**

Tad said five ambulance attendants would like to meet with the Selectboard individually in non public session. Tad will try to schedule them for Wednesday night. Tad said the Hollis Fire Chief is willing to meet with the Board on how they structured the combination of the fire and ambulance services. He will try to arrange for him to come in at 5:30 pm Wednesday.

### Non Public Session

Darrell moved, seconded by John to go into non public session under RSA 91-A: 3 (c) reputation and (d) acquisition of land.

On returning to public session, Darrell moved, seconded by Sue to seal the minutes. Voted yes 4-0.

Meeting adjourned at 9:05 pm.
