Minutes Selectboard Tuesday, May 28, 2013

Selectboard members Darrell Philpot, Karl Dowling, John Carr, Susan Adams and Brendan Denehy were present along with Town Administrator Tad Putney.

Also present were Ann Somers, Loring Webster, Pastor Damon Thomas and Calvin & Janice Sandford.

Town Boundaries

Ann Somers presented a binder of town boundaries she and Loring have found over the past couple of years. The Selectboard thanked them for all their work.

Minutes

John moved, seconded by Sue to approve the public session minutes of May 13th. Voted yes 5-0. Brendan moved, seconded by Karl to approve the three sets of non public session minutes of May 13th. Voted yes 5-0.

Warrants

The Selectboard approved Warrant # 22 in the amount of \$58,082.98 and payroll in the amount of \$42,085.17.

Conservation Commission

The Selectboard signed the appointment for Therry Neilsen-Steinhardt as an Alternate on the Conservation Commission until March 31, 2016.

Chapel/Brusch Hall

Darrell read a letter of thanks from Damon Thomas, Pastor of Cornerstone Bible Church for rental of the Chapel and Brusch Hall for services on Sundays. *Karl moved, seconded by John to authorize Darrell to sign a new rental agreement from June 1, 2013 thru May 31, 2014. Voted yes 5-0.*

PSNH

The Selectboard signed a pole license for PSNH to install/replace 17 poles on Russell Hill Road.

Groundwater Monitoring

Tad reported that three bids were received for the annual testing of the monitoring wells at the transfer station:

Civil & Environmental Consultants, Inc. of Raynham MA in the amount of \$2,500;

ChemServe of Milford NH in the amount of \$1,520.16;

Secondwind Water Systems of Manchester NH in the amount of \$3,090.

Brendan moved, seconded by Karl to award the groundwater monitoring of the wells at the transfer station to ChemServe for the amount of \$1,520.16. Voted yes 5-0.

Town Hall - Trim Work

Tad reported that Gavin Remodeling submitted a bid by last Friday's deadline. Alpine Environmental Inc submitted a bid today. Gavin is \$858/week for a carpenter and \$2,280/week for a lead carpenter. Alpine Environmental is \$2,200/week for all personnel.

Karl moved, seconded by John to award the contract to Gavin Remodeling. Voted yes 5-0. Tad was asked to check whether materials will be at cost.

Town Hall - Remodeling

Tad reviewed the proposed plan for the lower town hall to accommodate the Town Clerk/Tax Collector's Office, Building Inspector, Food Pantry and storage of Election materials. The Selectboard approved the plan. The next step is to put the project out to bid.

Rena Duncklee

Darrell announced that the Selectboard approved Rena's request to reduce her hours to 32 hours a week, four days a week beginning July 1st.

Library

Tad reported that LGC said the Selectboard can move money from the library budget to another department but Terry Knowles of the Attorney General's Office disagrees. She feels once a cash flow schedule is established following town meeting, no changes can be made.

Tree Warden

Tad said the tree warden line item will go over budget due to the tree that had to be removed at the intersection of Townsend Hill Road and Ten Rod Road (\$1,200) and two trees that need to be removed at Nissitissit Park. The overage will be absorbed by the general maintenance line item.

Non Public Session

Darrell moved, seconded by Karl to go into non public session under RSA 91-A: 3, II, (e) litigation and (c) reputation. Voted yes 5-0.

On returning to public session Darrell moved, seconded by Karl to seal the minutes. Voted yes 5-0.

Meeting adjourned at 8:45 pm.
