# Minutes Selectboard Monday, January 4, 2016

Selectboard members Susan Adams, Karl Dowling, John Carr and Brendan Denehy were present along with Town Administrator Tad Putney.

Sue opened the meeting with the Pledge of Allegiance.

# Minutes

John moved, seconded by Brendan to approve the public session minutes of December 21, 2015. Voted yes 3-0; Karl abstained.

Brendan moved, seconded by John to approve the 2 sets of non public session minutes of December 21, 2015. Voted yes 3-0; Karl abstained.

# Warrants

The Selectboard signed Warrant # 53 in the amount of \$35,800.75, Warrant # 1-2016 in the amount of \$780,015.32 and payroll in the amount of \$45,231.35.

#### **Budget Hearings**

The Budget Hearings for the 2016 proposed budgets will be held on January 19<sup>th</sup> and 20<sup>th</sup> at 7 pm.

# Treasurer

The Selectboard signed an appointment slip for Eric Bernstein as Treasurer. Term will expire at March 2016 Town Meeting.

# **NRSWMD**

Tad said the Nashua Regional Solid Waste Management District meets twice a year. He suggested Jim Solinas as Brookline's representative and Tad will be an alternate. *Karl moved, seconded by John to authorize Sue to sign the appointment. Voted yes 4-0.* 

#### Primary Election

**Tad** noted the Primary Election is February 9<sup>th</sup>. He said NHMA said no selectman is required to be at the election all day but he hasn't heard back from the Attorney General's Office. **Sue** said she feels it's important that at least one selectboard member be present. The others agreed. **Tad** will prepare a schedule.

# **Property-Liability Insurance**

As Property-Liability Trust will no longer offer Worker's Comp or Property-Liability insurance as of July 1, 2016, *Brendan moved, seconded by John to go with Primex starting July 1, 2016. Voted yes 4-0.* 

# **Hollis Energy Committee**

**Tad** said the Hollis Energy Committee is looking for a couple of Brookline volunteers to help with a project that will provide discounted solar installation in the spring. **Karl Dowling** volunteered to be one of the volunteers.

# **Blasting Ordinance**

**Tad** said Charlie is asking blasting companies to inform him when and where they are blasting and to submit a copy of their license and insurance certificate. **Tad** would like to amend the Blasting Ordinance to reflect these changes and review them at an upcoming meeting. **Karl** said his only concern is holding up a minor project if Charlie is not available.

# Pipeline Update

**Tad** said FERC has extended the deadline to file for intervening status to Friday, January 15<sup>th</sup>. He said the town has filed and the coalition will be filing before the deadline.

# Rte. 13/130 Turning Lane

**Tad** said the DOT expects to have the plans for the north and south turning lanes for the Rte. 13 and 130 intersection in February. The bids will go out late spring and the project should be done this summer.

# Hood Rd. Project

**Tad** reported that the state gave approval for the paving at the beginning of Hood Road where it intersects with Route 13.

Darrell arrived at the meeting. Sue moved, seconded by Brendan to go into non public session under RSA 91-A: 3, II (e) (litigation). Voted yes 5-0.

The board returned to public session. No minutes were taken as the session was with town counsel on legal issues.
