Selectboard members Darrell Philpot and Susan Adams were present along with Town Administrator Tad Putney. Brendan participated by speaker phone. Also present were Tom Humphreys, Ann Somers, Loring Webster and Drew Kellner.

Darrell opened the meeting with the Pledge of Allegiance.

Ann asked that neonicotinoid insecticides not be used on town property as they have been implicated as a potential contributing factor on honeybee decline. **Tad** will share this information with the landscapers working on town properties for input.

Sue said the Chili/Chowder/Soup Cook-Off was a huge success and thanked Valerie and those who worked on it.

Minutes

The minutes of February 16th were not approved as the participants of that meeting were not present tonight.

Warrants

The Selectboard signed Warrant #9 in the amount of \$69,580.26 and payrolls of \$47,676.65 and \$875.

Dupaw Gould Rd. Bridge

The Dupaw Gould Road Bridge is on the state's red list as needing repairs. **Tad** said he talked to the state and they agreed that the Bond Street Bridge is a priority and the Dupaw Gould Road Bridge is expected to be good for at least another 10 years.

Sidewalks

As requested by the Board, **Tad** provided a draft project plan for updating the 2009 Sidewalk and Trail Connection Plan.

2016 Proposed Budget

Tad said that Jerry Farwell suggested the snow plowing and sanding budget be lowered by \$50,000 based on the average numbers of the past 5 years. The Board agreed.

Brendan asked if we should look at the numbers for gas. It was agreed to lower the gas to \$1.90/ gallon and diesel to \$2.25/ gallon in the proposed budgets.




