Minutes Selectboard Monday, March 14, 2016

Selectboard members Karl Dowling, John Carr, Brendan Denehy and Tom Humphreys were present along with Town Administrator Tad Putney.

Also present were Ann Somers and Drew Kellner.

Karl welcomed Tom as a Selectboard member.

Karl opened the meeting with the Pledge of Allegiance.

Chairman

Karl said Darrell told him he was willing to continue as Chairman for the year, if elected. Karl nominated Darrell as Chairman, seconded by John. Voted yes 4-0.

Vice Chairman

Brendan nominated John as Vice Chairman, seconded by Karl. Voted yes 3-0; John abstained.

Minutes

Brendan moved, seconded by John to approve the public session minutes of February 16th. Voted 2-0; Karl and Tom abstained.

Warrants

The Selectboard signed Warrant #11 in the amount of \$777,730.12 and payrolls of \$46,794.40 and \$503.13. Also signed corrected police warrant of 3/2/16.

MS-232

The Selectboard signed the MS-232 "Report of Appropriations Actually Voted" for the Dept. of Revenue Administration.

Milfoil Agreement

Karl moved, seconded by Brendan to authorize John to sign the Milfoil Agreement for herbicide chemical treatment to Melendy Pond. Voted yes 4-0.

Petition

The Selectmen signed letters to President Obama, Senator Shaheen, Senator Ayotte, Representative Kuster, Representative Guinta, Senator Avard, Representative Flanagan and Representative Adams per the petition voted at Town Meeting.

Disbursements

The Board reviewed disbursements through February.

Job Description

The Selectboard reviewed the schedule and job description for Rena's replacement. There will be an internal job posting from March 16th thru March 23rd, an external job posting from March 23rd to April 8th with the Board making an appointment on May 9th and the new hire starting on May 16th.

TAP - Sidewalks

Tad said Meridian Land Services submitted the engineering study to the DOT and it was accepted. The preliminary engineering will take about 3 weeks. The sidewalks will go from So. Main Street on Route 130 to Bohanon Bridge Road and Old Milford Road from the top of Steam Mill Hill Road to Rocky Pond Road. *Karl moved, seconded John to authorize John to sign the agreement that the town will pay the additional \$13,600, if needed.*

Hazard Mitigation Plan

Tad said the Hazard Mitigation Plan needs to be updated every 5 years. The existing plan expires in August 2017. The NRPC has grant funds available. *John moved, seconded by Karl to have NRPC work with the town on updating the Plan. Voted yes 4-0.*

Signs

Brendan said someone requested to put a wooden advertisement sign on the concession sign last fall. Brendan asked what direction the Board wants to go. The sign ordinance doesn't address signs at the ball park. **Brendan** will address this with the planning board and keep the Selectboard advised..

Chili/Chowder/Soup Cook-off

The Board signed a letter to Valerie Rearick commending her on her work on the Cook-off and the Economic Development Committee.

Fire Dept.

The Board signed the NHRS Group II Position Certification Form for Jean-Paul Royea as a fire inspector/fire prevention officer.

Pipeline Update

Tad said 12 of the 13 towns in the Pipeline Coalition approved funds to oppose the pipeline.
