## Minutes Selectboard Monday, May 9, 2016

Selectboard members Darrell Philpot, Karl Dowling, John Carr, Brendan Denehy and Thomas Humphreys were present along with Town Administrator Tad Putney.

Also present was Ann Somers.

#### Public Input

**Ann** noted it was nice to see that people posted pictures of cleaning up the roads.

**Darrell** opened the meeting with the Pledge of Allegiance.

#### Minutes

John moved, seconded by Brendan to approve the public session minutes of April 25<sup>th</sup>. Voted yes 5-0. Brendan moved, seconded by John to approve the three sets of non public session minutes of April 25<sup>th</sup>. Voted yes 5-0.

Karl moved, seconded by John to unseal the 2<sup>nd</sup> set of non public session minutes. Brendan said we shouldn't unseal them yet. Karl moved, seconded by John to table the unsealing of these minutes until the next meeting. Voted yes 5-0.

**Brendan** noted that part of the discussion with the Fire Chief and Fire Wards was the request for them to submit a plan to the Board on the future of more full time people and what positions they would be.

#### Warrants

The Selectboard signed Warrant #19 in the amount of \$355,636.74 and payrolls of \$51,017.94 and \$6,628.13.

#### **Logging Operation – MBC Timber**

**Tad** said the logging operation is complete. Eversource has offered to contribute \$500, the Conservation Commission will contribute \$500 and the balance for MBC Timber would be \$900. Tad recommends that we return \$1,100 to MBC Timber and keep \$900 to repair the rail trail at the power line crossing. The Selectboard agreed. The work is expected to be done in June or July. The timber company is seeking an additional bid to do the work. Tad will keep the Board informed of any further developments.

#### **Disbursements through April**

The Board reviewed the disbursements through April. Tad said there are no issues of concern.

## Meetinghouse Hill Road

Oliver & Marianne Strong, Linda & Larry Saari of Meetinghouse Hill Road and Dan Butler were present to ask the Selectboard to do something to get the property at 11 Meetinghouse Hill Road cleaned up. Oliver submitted pictures of the property and a petition signed by neighbors asking the town to deal with the derelict house. Oliver said his family moved to 14 Meetinghouse Hill Road in 1977. An elderly couple lived at #11 for about ten years. Since then the property has been abandoned. A couple of years ago an ice storm caused extensions on both sides of the house to collapse. The owners were notified by the building inspector and they moved the debris behind the house. Nothing more has been done and the building continues to deteriorate. Oliver said they have been trying to sell their house for a year and a frequent question to the realtor is about the derelict house across the street. Linda said a rat was seen in her front yard and when spooked, it went toward the abandoned house. She said she brought up this issue last year. Tad suggested a letter be sent to the property owners to clean up the property. Darrell said we should get code enforcement and emergency services involved regarding safety issues and include them in the letter. Darrell thanked them for bringing this to the Selectboard's attention. Karl asked that Tad also try calling the owners. The Board agreed. Brendan asked that this be an agenda item for the next meeting.

## 250th Anniversary

Sheryl Corey was present with an update on the town's 250<sup>th</sup> anniversary. She said the committee decided on the week of August 3 – August 11, 2019 for the week long celebration. She said they would also have events throughout the year. They will be contacting all organizations in town to participate. The committee estimated they would need between \$75,000 and \$100,000, the most expensive items being the parade and fireworks.

#### Route 130/Cross Road Intersection

Tad reported that Chief Quigley reached out to the Dept. of Transportation about increased signage at the intersection. Tad said he also sent a letter to Mr. Lambert at the DOT. He said the DOT had three options in 2011 to improve the intersection. The State has a new program with money included. We may need to wait until January to apply to this program. The DOT is meeting this week and may allow the alternatives to be considered this year. Karen Buretta and Cheryl O'Donnell of Cross Road were present. Karen said people are not familiar with the intersection. She feels making Cross Road a one way street will cause more head on collisions. She said correct signs should be installed before any changes to the road are made. Cheryl said a sign is needed warning people that Cross Road is a left turn and Route 130 is the main road. She said the speed limit should be lowered. Tom asked what the effect would be of Cross Road being a one way street. Karen said it would lower the value of her home. Ann agreed proper signage should be installed.

#### **Town Lawns**

Michele Decoteau and Trish Thompson were present. Tad said he reached out to Rich Vertullo of the Recreation about the use of neonicotinoids on town lawns as he oversees maintenance of the town field. Rich said he uses it in a granular form so it doesn't spread and it is not applied when the clover is in bloom to avoid direct contact with honeybees. Tad said he hasn't heard back from Travis Wilson who takes care of town lawns on alternative products that could be used. Trish said that chemical stays in the soil for 10 years and that it has been banned in Maine. Trish and Michele said neonicotinoids have

been implicated as a potential contributing factor to honeybee decline. Tad will check with other towns on what they are using.

#### **Bond Street Bridge**

Tad reported that he received three proposals for evaluating engineering and construction costs to repair the Bond Street Bridge. The proposals range from \$6,800 to \$26,900. Karl moved, seconded by Brendan to go with Quantum Construction at \$6,800. Darrell suggested including a 20% management discrepancy fee of \$1,360 for a total of \$8,160. Seconded by Brendan. Voted yes 5-0.

#### Pipeline Update

**Tad** said the Coalition wrote to FERC asking them to have Kinder Morgan withdraw their application for the pipeline. He said the town has spent about \$30,000 of the \$95,000 raised to fight the pipeline. The Coalition would like to continue meeting perhaps monthly. The Board agreed as long as no more money is spent. **Brendan** said Milford sent a letter for repayment for what they've spent on the pipeline. **Karl** said we should send a bill. **Darrell** said send a bill to FERC and Kinder Morgan.

#### Eversource

**Tad** said Eversource cut trees along the power lines and were asked to replace some of them. He said Eversource agreed to plant an oak tree at the town hall to replace the one that died and another one at the safety complex.

#### **Safety Complex Roof**

Tad said he received 2 viable bids for the safety complex roof. He said we have two options: 1. Reshingle the entire south side of the ambulance with long lasting shingles; or 2. Re-shingle the entire building. Tad recommends that we go with Vaillancourt with 30 year shingles, a better warranty, and they did the library and RMMS gym. To do the entire roof would cost about \$26,000 more than was budgeted. He said we would have to defer other projects such as the columns at the town hall, the fire department ramp and/or the painting of the steeple at the library. Darrell said he would like to get a legal opinion on whether the warranty can be enforced. *Karl moved, seconded by John to re-shingle the entire roof of the safety complex for a cost of \$57,590 based on getting a legal opinion that the warranty is enforceable. Voted 5-0.* When asked where the Board wanted get the additional \$26,000, they left it up to Tad.

#### Rena's Retirement

**Tad** said he checked with Rena on her availability for a get together for her retirement at the end of June. The afternoon of Saturday, June 18<sup>th</sup> was set.

#### **Non Public Session**

Darrell moved, seconded by John to go into non public session under RSA 91-A: 3 II (b) hiring (c) reputation, and (e) litigation. Voted yes 5-0. On returning to public session Darrell moved, seconded by John to seal the minutes. Voted yes 5-0.
